28 February – More than 100 entrepreneurs and heads of SMEs came together at a breakfast networking session, which offered employers practical tips and shared the benefits of implementing fair employment practices. Jointly organised by the Association of Small and Medium Enterprises (ASME) and the Tripartite Centre for Fair Employment, the session also gave participants the opportunity to interact and exchange views on the best ways to implement fair employment strategies in their workplaces.

Pioneer 'Fair Employers', Cherie Hearts Group, GMP Group and Jason Electronics shared their experiences.

Steps Taken By Fair Employers

Cherie Hearts Group – Dr. Sam Yap, Group CEO and Founder

- Revamped their job application form so that no question on race, religion, age or gender is asked.
- Actively discourages relationship-based recruitment.
- Uses a third party to conduct exit interviews to properly understand reasons behind every resignation.

The GMP Group – Mr. Josh Goh, Manager (Corporate Services)

- Ensures Equal Opportunity is the foundation of its business ethics.
- Recognises that once fair employment practices are in place, HR can focus on more strategic issues such as employer branding and retention.
- In-house experience shows that diverse groups tend to outperform homogenous ones.

Jason Electronics – Mr. Ooi Chee Kong, Human Resource Manager

- Believes hiring decisions should only be based on performance and merit.
- Recognises that adopting fair employment practices is progressive.
- Identifies training needs to meet the business objectives.

So inspiring was the session that it led to 27 SMEs signing the Employers' Pledge of Fair Employment Practices on the spot!



Introducing the Fair Employment Advocates Programme

23 January – The Fair Employment Practices Seminar is specially designed for advocates from pledged companies to demonstrate how a company's productivity and performance can be raised with well-planned and well-designed recruitment practices. Discussing non-discriminatory recruitment procedures, employers learned about the dos and don'ts of writing job advertisements, conducting interviews, developing job descriptions and more.

At a recent breakfast networking session, Mr. Josh Goh, Manager (Corporate Services) from the GMP Group, presented some of the fair employment practices adopted by the group. An amateur runner, Josh shared an analogy which inspired many at the session:

"Adopting fair employment practices is like running a marathon; you have to fix your mind on completing the race. There may be moments of despair, where the finish line seems too far away and impossible to get to. Likewise, when adopting fair employment practices, it is important to keep focused on your goals, and not be disheartened by any obstacles along the way. The reward is a more competitive workforce, hired based on merit, which in today's business environment allows a company to differentiate itself from competitors."
